2015 Mosquito Control Workshops

The Annual Nebraska Mosquito and Vector Control Association (NMVCA) Mosquito Control Workshops will be held in Lincoln on June 2th, in Burwell on June 3rd, in Minden on June 4th (*New Location!! Minden Fairgrounds*) and Gering on June 5th. The educational portion for all four workshops will be from **9:00 am to 1:00 pm**. Van Diest Supply will conduct a calibration and droplet testing of spray trucks in the afternoon at each site. Registration will begin at 8:30 am. Lunch is included with each registration.

The goal of these workshops is to provide training necessary to help deal with community mosquito control problems. **Topics include: Mosquito Biology, Larviciding, Adulticiding, Safe Chemical Handling, proper record keeping and Legal Issues.**

These workshops are open to all interested individuals. Workshop registration fees are listed on the registration form (page 3). Pre-registration is requested but payment for all fees can be made at the door. All checks must be made payable to the NMVCA and payment must be made no later than the day of the workshop.

The **VAN DIEST SUPPLY COMPANY** will provide proper calibration and droplet testing for truck or trailer-mounted mosquito control equipment. This is important for the current National Pollutant Discharge Elimination System permits. Proper calibration and correct droplet size are important for the legal operation of equipment used to control adult mosquitoes. These workshops will provide a good opportunity to get your equipment ready for the upcoming season.

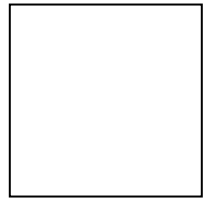

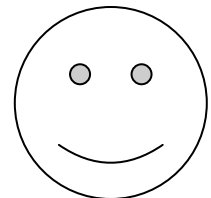
